## Part A: Pupil premium strategy plan

### Statement of intent

The Orchards School is a safe, caring environment where all members of our community are encouraged to trust, flourish and grow. We enjoy exploring new ideas collaboratively in a mutually respective engaging setting, in pursuit of excellence, achievement, and pride.

- We believe that potential is not something for our pupils to 'fulfil' but instead, is an ever-growing target, adapting and evolving with each person regardless of starting point: cultural, educational, or health care.
- We know that quality first teaching improves outcomes for all children.
- We are committed to pace of progress of all our pupils.
- We rigorously and routinely analyse data to identify well-being and learning needs and any other barriers to learning.
- We enable provision of focused support to ensure pupils move on from their individual starting points at a realistic pace.
- We know it is essential that children learn new skills and knowledge in a meaningful way, ensuring new material is built on secure foundations for independent and consistent application.
- We continuously endeavour to actively involve parents in their child's education, highlighting the importance of attending school every day.
- We have based our approach on the Education Endowment Foundation guide to supporting school planning, a tiered approach and their pupil premium toolkit.

### Challenges

Challenge number	Detail of challenge
1. Language deprivation	<ul> <li>Language Link has identified children that require targeted intervention to develop language skills</li> </ul>
	<ul> <li>A significant proportion of pupils enter school with high levels of language deprivation and weak oral language and communication skills. Diagnostic assessment tools assess pupils' language acquisition and has consistently illustrated this gap on school entry. Left unchallenged, this and a narrower vocabulary would remain a barrier for many throughout their primary years and future learning.</li> </ul>

2. Exposure to early reading/Phonics and writing	Phonics assessment indicates that the proportion of children meeting expected standards at Year 1 is less than standards nationally; particularly for those disadvantaged children. By the end of EYFS, without systematic and robust phonics teaching, the area of learning preventing children achieving a good level of development is most likely reading and writing. The school has a significant proportion of Early Career Teachers and Phonics Teaching Assistants who have experienced an inconsistent approach to their teaching practice as a result of the disruption caused by Covid.	
3. Attendance	<ul> <li>Attendance of disadvantaged children is below that of non- disadvantaged children. This gap has widened since the pandemic.</li> </ul>	
4. Social, Emotional and Mental Health Regulation	<ul> <li>In some cases, children have lower levels of emotional literacy than their non-disadvantaged peers.</li> </ul>	
5. Limited Experiences	<ul> <li>In some cases pupils lack the experiences that their non- disadvantaged peers may have had outside school and as a result vocabulary can be less broad and children may lack context for their learning.</li> </ul>

# Part B: Review of outcomes in the previous academic year

### Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2022 to 2023 academic year.

- CPD has ensured continued focus on staff training and coaching in phonics, reading and quality first teaching, including a targeted training programme for all new staff. All staff have had high expectations for teaching and learning. Year group leaders and subject leaders met regularly to plan high quality and engaging lessons. Expertise, due to these meetings were shared for planning and delivering a broad and balanced curriculum.
- In addition, CPD and lesson observations have supported all staff, and particularly new staff and ECTs in the pedagogical approaches to the teaching of reading and writing. As a result, all stakeholders understand the importance of reading and how the reading curriculum progresses from learning to reading, into comprehension.
- Through a targeted development cycle of professional development meetings, coaching and Teams Around the School, all staff have received ongoing training exploring strategies that support pedagogical approaches to teaching and learning. This has been reflected in pupil progress and book looks.
- Budget planning enabled all year groups to plan a visitor or a visit for each topic delivered which allowed children to experience learning beyond the classroom ,put learning within a context and develop cultural capital. Visitors to school included The Fire Brigade, Ambulance and Police, Alex Woods Musician, The Stone Age and Roman Age experiences, and the school nurse.
- Pupil Premium money last year was allocated towards extra staffing capacity to address and meet identified needs, with specific identified non-teaching staff supporting attendance.
- Following reviews of regular data tracking and analysis we are confident that staff training, coaching and targeted phonics intervention improved pupil attainment and progress.
- As a result of our regular analysis of behaviour, pupil and staff voice, we know that SEMH emotional regulation, along with outside agency Counselling and Therapy sessions has had a positive impact on pupil engagement in learning.

- Parental confidence in our school is rising through increased engagement with staff to support their children in learning and attendance.
- Careful attention to pupil welfare has resulted in PP funds being allocated to support wider curriculum experiences such as residentials and educational visits, early drop off and late leavers provision.
- Curriculum provision project for Year 1 has been created around Early Excellence research, therefore teachers are able to implement the curriculum intentions throughout the next academic year. In addition to this, training on the new Early Years framework, alongside Trust wide bespoke curriculum coverage document has ensured that all Early Years teachers are confident of the key changes and outcomes. Bespoke planning provision has been implemented by Early Years leaders and staff and Trust Reviews have highlighted a strength in practice within EYFS
- Small group tuition has been used to support the teaching of phonics for key pupils, the majority of which were pupil premium.
- Interventions linking to Speech and Language have been prioritised this academic year to support the most vulnerable learners.
- As a result of CPD and dedicated briefing time, teaching staff are more aware of persistent absence children within their care and now promptly identify their absence to both the Attendance Lead and Office staff.
   Furthermore, staff are more vigilant in identifying prolonged absence or patterns and this is promptly addressed with parents. In class, children have been given reward systems to increase attendance, as well as keeping attendance high profile, through weekly assemblies and newsletter articles.
- Additional supporting to develop emotional regulation has been provided through support from the Educational Phycologist to support children with strategies and recognising their own emotions and beginning to recognise how they impact on others. As a result of this specific children have been identified and SEMH assessment completed.
- Targeted support for Key Individuals has been delivered by the Trust Pastoral Behaviour Specialist. As a result, children are now more confident in strategies to support them in social settings, including within their friendship groups as well as managing their emotions
- Clarinet and Oboe lessons have taken place within Year 3 and Year 4. These groups have significant PP numbers. They were given the experience of learning a new musical instrument and broadening and developing their knowledge of curriculum, through practical, high-quality teaching. Additional opportunities were provided for the children experience music played by professional musicians and learn about music in context.

- As part of a whole school development, each class has received sessions working alongside a trained forest school provider. This has developed their understanding and experiences that can take place outside of the classroom. In year 4 this has also built upon their outdoor learning experiences that they developed over the residential. 44.2% of children attending were PPG children who attended the residential as a subsidised residential. As a result, they received the opportunity to develop skills and experiences that are beyond their immediate social reach and has developed their knowledge and place in the world.
- After school clubs commenced from October 2022, providing children with a range of wider curriculum experiences including, mindfulness, drama, art, football, cheerleading, choir and computing skills.
